The following changes and/or additions shall be made to the Plans, Specifications, and Contract Documents for the above referenced project. Bidder shall acknowledge receipt of this Addendum by signing below and returning this Addendum with the Bid.

1) GENERAL

- a) The bid schedule shall be replaced with the attached copy. A 2nd base bid (Base Bid B) will be accepted for multi-jet meters for 5/8x3/4" through 2" sizes. Base Bid A will still be accepted for ultra-sonic, mag, or solid-state meters for all sizes as called for in the specifications. Bidders may submit a bid for Base Bid A and/or Base Bid B.
- b) For bidding purposes, it can be assumed that the 3" meter to be replaced is currently a turbine type meter with an existing by-pass connection.
- c) The Owner shall have the option to keep old meters and boxes. Disposal of old meters and/or boxes by Contractor shall be provided by the Contractor if Owner elects to not keep the old meters and/or boxes.
- d) The Owner currently uses Incode billing software.
- e) Contractor shall be responsible for storage of all materials. Payment for stored material is possible, provided that the contractor provides insurance coverage for the stored material as well as copies of material invoices from vendors.
- f) The existing Master Meter system is read via a drive-by system.
- g) If existing meter box(es) are utilized, contractor shall be responsible for any modification of the existing box or lid as required for transmitting meter signal. A majority of existing meter lids are metal.
- h) Existing meters are connected with straight or angle type meter stops and couplings. Meter setters are not utilized currently.
- i) Existing 2" meters have flanged connections.
