1) BID SCHEDULE

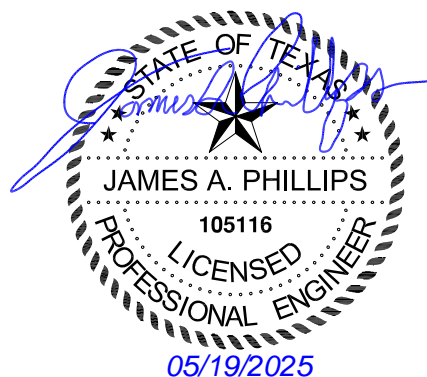
- a) An additional Bid Schedule (Bid Schedule D) is being included for an electromagnetic style flow meter.
